A – BIOGRAPHICAL INFORMATION - BIOGRAFSKI PODACI

Dr. Ibrahim Dursun was born on August 25th, 1971. in Biga, Republic of Turkey. He began his university education at the Faculty of Economics and Administrative Sciences at Dokuz Eylul University in Republic of Turkey, where in 1993 he obtained Bachelors degree. He continued his academic education at the Institute of Social Sciences of Afyon Kocetepe University, Republic of Turkey, where he got Master's degree in public finance in 1995. In 2002. Dr Dursun was awarded with the PhD diploma in Public Finance at the Institute of Social Sciences of Dokuz Eylul University in the Republic of Turkey.

On June 10, 2003, Dr Dursun was appointed as a assistant professor at Afyon Kocetepe University in Turkey, where he worked until 2005, when he continued his working engagement with Usak University of the Republic of Turkey, until 2010. Within the framework of the Afyon Kocetepe University and the Uşak University, Dr. Dursun was teaching courses within the field of public finance, public budgets and public economics.

Since 2011, Dr. Dursun has been appointed as an associate professor at the Turkish National Police Academy (Institute of Security Sciences) as home main higher education institution, where he taught courses related to management, public finance and financial crime cases.

In addition to his rich academic experience at the mentioned higher education institutions in the Republic of Turkey, Dr. Ibrahim Dursun was engaged for six months as a visiting professor at the University of Nottingham in the United Kingdom during the academic year 2012-2013. Also, in the period from 2015 to 2017, Dr. Dursun was engaged as a course holder in the field of Economics at the Faculty of Business and Public Administration, as well as at the Faculty of Law of the International University of Sarajevo.

Finally, in June 2016, Dr. Dursun was appointed into the academic title of full professor at the Turkish National Police Academy's (Institute of Security Sciences).

Dr. Dursun is member of various professional and scientific panels and committees. Speaks and writes in English and Turkish.

A – BIOGRAPHICAL INFORMATION / Biografski podaci

Dr. Ibrahim Dursun rođen je 25.08.1971. godine u mjestu Biga, Republika Turska. Svoje univerzitetsko obrazovanje započinje je na Fakultetu ekonomskih i upravnih nauka na Dokuz Eylul univerzitetu u Turskoj gdje je 1993. godine stiče titulu Bachelor of Arts. Svoje akademsko obrazovanje potom nastavlja na Institutu za društvene nauke Afyon Kocetepe Univerziteta, Republika Turska, na kojem 1995. godine stiče i zvanje magistra iz oblasti javnih finansija. Diplomom doktora nauka iz oblasti javnih finansija dr Dursun stiče 2002. godine na Institutu za društvene nauke Dokuz Eylul univerziteta u Republici Turskoj.

Dr Dursun je 10.06.2003 imenovan u naučnonastavno zvanje docenta na Afyon Kocetepe Univerzitetu u Turskoj na kojem radi do 2005. godine od kada u istom zvanju nastavlja svoj radni angažman pri Usak univerzitetu Republika Turska - sve do 2010. godine. U okviru Afyon Kocetepe Univerziteta i Usak univerziteta dr. Dursun predaje nastavne predmete iz oblasti javnih finansija, javnog budžeta i javne ekonomije.

Od 2011. godine imenovan je u zvanje vanrednog profesora pri svojoj matičnoj visokoškolskoj ustanovi *Turkish National Police Academy* (Turska nacionalna policijska akademija), gdje predaje predmete vezane za rukovođenje, javne finansije i finansijski kriminal.

Pored bogatog akademskog iskustva na navedenim visokoškolskim ustanovama u Republici Turskoj, Dr. Ibrahim Dursun bio je angažovan šest mjeseci kao gostujući profesor na Univerzitetu u Nottinghamu u Ujedinjenom kraljevstvu u toku akademske 2012/13. godine. Također, u periodu od 2015. do 2017. godine, Dr. Dursun angažiran je i kao nastavnik na nastavnim predmetima iz naučne oblasti Ekonomija na Fakultetu menadžmenta i javne uprave kao i na Pravnom fakultetu Internacionalnog univerziteta u Sarajevu.

Naposlijetku, u junu 2016. godine dr. Dursun imenovan je i u zvanje redovnog profesora pri Institutu za sigurnosne studije Nacionalne policijske akademije Republike Turske (*Turkish National Police Academy*).

Dr. Dursun je član brojnih naučnih i stručnih panela i komisija. Govori i piše na engleskom i turskom jeziku.
